

VILLAGE OF COLEMAN

ORDINANCE NUMBER 2005-02

AN ORDINANCE AMENDING CHAPTER 94-4 (C) AND CHAPTER 94-8 OF THE MUNICIPAL CODE OF ORDINANCES OF THE VILLAGE OF COLEMAN, WISCONSIN GOVERNING ALCOHOLIC BEVERAGES.

THE VILLAGE BOARD OF THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN DOES HEREBY ORDAIN THAT CHAPTER 94-4 (C), BE AMENDED TO READ AS FOLLOWS:


- C. Any person violating Subsection A or B is subject to the following penalties:
- (1) For a first violation, a forfeiture of not less than \$100.00 nor more than \$200.00, as stated in SS 125.07 (4)(c)(1), suspension of the person's operating privilege as provided under SS 343.30 (6) (b) 1., Wis. Stats., participation in a supervised work program under Subsection D or any combination of these penalties.
 - (2) For a violation committed within 12 months of one previous violation, either a forfeiture of not less than \$200.00 nor more than \$300.00, as stated in SS 125.07 (4)(c)(2), suspension of the person's operating privilege as provided under SS 343.30 (6) (b) 2., Wis. Stats., participation in a supervised work program under Subsection D or any combination of these penalties.
 - (3) For a violation committed within 12 months of two previous violations, either a forfeiture of not less than \$300.00 nor more than \$500.00, as stated in SS 125.07 (4)(c)(3), revocation of the person's operating privilege as provided under SS 343.30 (6) (b) 3., Wis. Stats., participation in a supervised work program under Subsection D or any combination of these penalties.
 - (4) For a violation committed within 12 months of three or more previous violations, either a forfeiture of not less than \$500.00 nor more than \$1,000.00, as stated in SS 125.07 (4)(c)(4), revocation of the person's operating privilege as provided under SS 343.30 (6) (b) 4., Wis. Stats., participation in a supervised work program under Subsection D or any combination of these penalties.

ADDITIONALLY, THE VILLAGE BOARD OF THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN DOES HEREBY ORDAIN THAT CHAPTER 94-8 (C), BE AMENDED TO READ AS FOLLOWS:

- C. A person who violates this section is subject to the following penalties as stated in Wis. Stats., 125.07(1)(b)(2)(a-d):
- (1) Required to forfeit not more than \$500.00 if the person has not committed a previous violation within 30 months of the violation.

- (2) Fined not more than \$500.00 or imprisoned for not more than 30 days or both if the person has committed a previous violation within 30 months of the violation.
- (3) Fined not more than \$1,000.00 or imprisoned for not more than 90 days or both if the person has committed 2 previous violations within 30 months of the violation.
- (4) Fined not more than \$10,000.00 or imprisoned for not more than 9 months or both if the person has committed 3 or more previous violations within 30 months of the violation.
