



Ordinance Number 2018-04**


AN ORDINANCE AMENDING CHAPTER 220-23 (D) OF THE MUNICIPAL CODE OF ORDINANCES OF THE VILLAGE OF COLEMAN, WISCONSIN GOVERNING ISSUANCE OF WORTHLESS CHECKS

THE VILLAGE BOARD OF THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN DOES HEREBY ORDAIN THAT CHAPTER 220-23 (D) BE AMENDED TO READ AS FOLLOWS:

D. Any person violating any provisions of this section shall forfeit not less than \$50 together with the costs of prosecution, and in default of payment shall be imprisoned in the Marinette County Jail until forfeiture and costs are paid but not to exceed the maximum length of time authorized by Wisconsin State Statutes.

# VILLAGE OF COLEMAN

## ORDINANCE NUMBER 2009-05

AN ORDINANCE AMENDING CHAPTER 220-21 (D), CHAPTER 220-23 (A), AND CHAPTER 220-23(D) OF THE MUNICIPAL CODE OF ORDINANCES OF THE VILLAGE OF COLEMAN, WISCONSIN GOVERNING RETAIL THEFT AND ISSUANCE OF WORTHLESS CHECKS.

THE VILLAGE BOARD OF THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN DOES HEREBY ORDAIN THAT CHAPTER 220-21(D), BE AMENDED TO READ AS FOLLOWS:


D. Penalty. If the value of the merchandise does not exceed \$150, any person violating this section shall forfeit not more than \$250. If the value of the merchandise is greater than \$150 not to exceed \$500, any person violating this section shall forfeit not more than \$300. If the value of the merchandise is greater than \$500, any person violating this section shall forfeit not more than the amount mandated in the Wisconsin State Statutes.

ADDITIONALLY, THE VILLAGE BOARD OF THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN DOES HEREBY ORDAIN THAT CHAPTER 220-23 (A) and (D), BE AMENDED TO READ AS FOLLOWS:

A. Whoever issues any check or other order for the payment of money which, at the time of issuance, he or she intends shall not be paid is guilty of a violation of this section.

D. Any person violating any provisions of this section shall forfeit not less than \$50 if the worthless check is for an amount equal to or less than \$150 and shall forfeit not less than \$100 if the worthless check is for an amount greater than \$150 and less than \$500 and shall forfeit not less than \$150 if the worthless check is for an amount greater than \$500, together with the costs of prosecution, and, in default of payment, shall be imprisoned in the Marinette County Jail until forfeiture and costs are paid but not to exceed the maximum length of time authorized by Wisconsin State Statutes.
